Chris Boucha brought up his contract for mowing the grass at the lagoons had expired. He agreed to keep his price the same. Wayne Davis's contract had expired also. He is keeping all his prices the same, but adding 50.00 a cut for the cemetery. In the contracts, we have the ability to extend their contracts without posting bids. Motion to extend the contracts to continue made by Treasurer Olsen, second by Clerk Matelski. Motion passed.

Fire Chief Peterson brought up the shoulder fiasco. Treasurer Olsen will get in touch with Dirk Heckman.

Jason Lowetz brought up using the fairgrounds as a starting point for a 166 mile bike race he is putting together for Saturday September 11th. 300 participants have signed up so far. He asked about getting power to the outside property. Treasurer Olsen will contact Cloverland to get a price. Supervisor Serwach wants to make sure our liability

insurance jives with the insurance Jason already has on the event. This will be checked into.

Mike Sabo complained about late night shenanigans going on at the Brevort Township Cemetery that is disturbing their sleep. He is asking that the township install signs stating that the cemetery is closed at dark to try and stop this activity. Someone will check with the sign guy for a price.

Trustee W Orr reported that the trees around the pavilion at the township park is destroying the roof. Trying to find a contractor to do the job and the price will be looked into.

Fire Chief Peterson brought up 2 derelict building in the township. One is owned by Al Colegrove and the other one is the Erskine store who's owners aren't known as of yet. Supervisor Serwach suggested that the township attorney Tom Evasheski send out letters stating that they be torn down and cleaned up. Motion to send a letter to Mr. Colegrove was made by Trustee W Orr. Second by Trustee T Orr. Motion passed.
