BOARD MEETING  
November 14, 2022

The meeting was called to order by Supervisor Serwach at 5:50 pm by the Pledge of Allegiance.

All Board members were present.

Clerk Matelski read October meeting minutes. Motion to approve minutes as read made by Trustee Tabitha Orr, seconded by Trustee William Orr. . Motion granted.

Clerk Matelski read the bills. Motion to approve bills as read made by Trustee T. Orr and seconded by Treasurer Olsen.. Motion granted.

Treasurer Olsen read the Treasurer's report for October. Motion to approve the reports by Trustee Wm. Orr. .Seconded by Clerk Matelski. Motion granted.

Supervisor Serwach stated that a new FEMA ordinance for flood plain insurance must be approved for people to purchase flood insurance. Ordinance #24 was submitted. Motion to approve made by Clerk Matelski, seconded by Trustee W. Orr. Motion passed.

Treasurer Olsen stated that he would like to change the winter tax bill regarding underpayment and over payment. The present amount is \$1.00 and he would like to increase the amount to \$2 in order to avoid the expense of having to return funds over \$1.00. Motion to approve same made by Trustee W. Orr, seconded by Clerk Matelski. Motion passed.

New Business: Daryl Orr stated that he would like the township to place a Dead End sign for Knowles Road. This would prevent drivers from having to turn around at the end of the road. Since the road has been upgraded, drivers not from the area assume it is a through road. A cost of approximately \$110.00 would be needed to purchase and install said sign. Steve Bird stated that the State of Michigan might make the sign at no cost. Brian Olsen or Daryl Orr will contact the Dept. Of Transportation regarding this matter. If the State of Michigan will not make the sign, a motion to purchase same for \$110.00 was made. Motion by Trustee T. Orr made, seconded by Treasurer Olsen, motion approved.

Trustee T.Orr requested the sum of \$300.00 for the annual Children's Christmas Party.Motion by Treasurer Olsen,made, seconded by Clerk Matelski. Motion passed.

Treasurer Olsen previously reported that the Ford garage in St. Ignace was not able to order new vehicles yet. Supervisor Serwach stated that Boyd Bigger suggested that the old truck presently in operation by the Sewer Dept. be repaired. Supervisor Serwach stated that new tires have been ordered and that replacement parts would cost between \$1900.00 and \$2000.00. While repairs are being made, Supervisor Serwach is letting the Township use his pick-up for service calls.
