BREVORT TOWNSHIP Ordinance No. 2

An Ordinance Relating to Snow Removal on Sidewalks of Moran Avenue.

The Township of Brevort Ordains:

SECTION 1. It shall be unlawful for the abutting land owners to allow snow or ice to remain on sidewalks in front of their premises on Moran Avenue, Brevort Township.

SECTION 2. Any person convicted of violating any provision of this ordinance shall be guilty of a misdemeanor, punishable by a fine of not more than \$100.00 or by imprisonment in the county jail for not more than 90 days or by both fine and imprisonment.

SECTION 3. This ordinance shall take effect 30 days after the first publication thereof.

PASSED AND APPROVED by the Brevort Township Board, at a special meeting held on the 26th day of August, 1961, and ordered to be published in The Republican-News, a newspaper published in the City of St. Ignace, Michigan, and circulating within Brevort Township, Mackinac County, Michigan.


The Township of Brevort Ordains:
