Ordinance No. 6

An Ordinance Amending Ordinance No. 3 Regulating the Speed of Motor Vehicles in Brevort Township.

The Township of Brevort Ordains: SECTION 1. Section 3 of Ordinance No. 3 shall be amended to read, "It shall be unlawful for the owner or operator of any motor vehicle to operate such vehicle at a rate of speed in excess of 25 statute miles per hour on the Brevort Lake Road from John Christensen's Resort to the end of the blacktop, which is to the east and west quarter line of Section 2 Town 41 North, Range 5 West, Brevort Township, Mackinac County, Michigan."

SECTION 2. Ordinance No. 3 as enacted on the 26th day of August, 1961 shall remain in full force and effect in all other respects.

SECTION 3. Any person convicted of violating any provision of this ordinance shall be guilty of a misdemeanor punishable by a fine of not more than \$100.00 or by imprisonment in the County Jail for not more than 90 days or by both fine and imprisonment.

SECTION 4. This ordinance shall take effect 30 days after publication thereof.




