FOR THE TOWNSHIP OF BREVORT**

O R D I N A N C E 720. 7

Ordinance to secure the public peace, health, safety and interest for the residents and property owners for the Township of Brevort, County of Mackinac.

THE BREVORT TOWNSHIP BOARD ORDAINS:

Section 1: From and after the effective date of this ordinance it shall be unlawful for any person or group of persons to hunt, molest, kill or attempt to kill any bears on township dump land described as follows:

S $\frac{1}{2}$ of SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 30 Town 42 North, Range 4 West, Brevort Township, Mackinac County, Michigan, otherwise known as the Brevort Township Dump.

Section 2: Anyone who violates the terms and conditions of this ordinance shall upon conviction be punished by a fine not to exceed \$100.00 or by imprisonment of not more than 90 days in the County Jail or both at the discretion of the Court.

Section 3: That this ordinance shall become effective on the fifteenth day of August, 1971.

BOARD ORDAINS**

Section 1: From and after the effective date of this ordinance it shall be unlawful for any person or group of persons to hunt, molest, kill or attempt to kill any bears on township dump land described as follows:

Section 3: That this ordinance shall become effective on the fifteenth day August, 1971.

Passed and approved by the Brevort Township Board at the regular meeting held on the 9th day of July, 1961, and ordered to be published in the Republican-News, a newspaper published in the City of St. Ignace, Michigan, and circulating within Brevort Township, Mackinac County, Michigan.
