OF THE TOWNSHIP OF BREVORT
UNDER THE PROVISIONS OF THE
STATE CONSTRUCTION CODE ACT**

ORDINANCE NO. 8

An ordinance to designate an enforcing agency to discharge the responsibilities of the Township of Brevort under the provisions of the State Construction Code Act.

The Township of Brevort ordains:

Section 1. Agency Designated. Pursuant to the provisions of Sec. 9 of Act 230 of the Public Acts of 1972, the building official of the Township of Brevort is hereby designated as the enforcing agency to discharge the responsibilities of the Township of Brevort under Act 230 of the Public Acts of 1972, State of Michigan. The Township of Brevort hereby assumes responsibility for the administration and enforcement of said Act throughout its corporate limits.

Section 2. All Ordinances inconsistent with the provisions of this Ordinance are hereby repealed.

Section 3. This Ordinance shall be effective after legal publication and in accordance with provisions of the Act governing same.
