Brevort Township Ordinance No. 13 ADOPTED: December 7, 1984 EFFECTIVE: Immediately An Ordinance to designate an enforcing agency to discharge the responsibilities of the UNIT OF GOVERNMENT of Brevort Township under the provisions of the STATE BUILDING CODE, STATE ELECTRICAL CODE, STATE MECHANICAL CODE Act. (Act 230 of the Public Acts of 1972, as amended.)

The UNIT OF GOVERNMENT of Brevort Township ordains.

#### Section I

Agency Designated. Pursuant to the provisions of the Michigan Building Code, Michigan Electrical Code, Michigan Mechanical Code, in accordance with Act 230 of the Public Acts of 1972, as amended, the Brevort Township Board official of the UNIT OF GOVERNMENT of Brevort Township is hereby designated as the enforcing agency to discharge the responsibilities of the UNIT OF GOVERNMENT of Brevort Township under Act 230 of the Public Acts of 1972, as amended, State of Michigan. The UNIT OF GOVERNMENT of Brevort Township hereby assumes the responsibility for the administration and enforcement of said Act throughout.

#### Section II

This Ordinance shall be effective after legal publication and in accordance with provisions of the Act governing same.
