ORDINANCE NUMBER 8,
ADOPTED 10-18-74,
AND TRANSFER RESPONSIBILITY AND
ENFORCEMENT OF ITS BUILDING AND
CONSTRUCTION CODE TO THE BUREAU
OF CONSTRUCTION CODES UNDER THE
PROVISIONS OF THE STATE
CONSTRUCTION CODE ACT OF 1972**

(ACT 230 OF THE PUBLIC ACTS OF 1972, AS AMENDED)

BREVORT TOWNSHIP Ordinance Number 18

An ordinance to repeal the Brevort Township Board Ordinance Number 8, adopted 10-18-74, and transfer responsibility for the administration and enforcement of its Building and Construction code to the Bureau of Construction Codes under the provisions of the State Construction Code Act of 1972 (Act 230 of the Public Acts of 1972, as amended).

The Brevort Township Board, Mackinac County, Michigan hereby ordains:

Section 1. Pursuant to the provisions of section 9(7) of the State Construction Code Act of 1972, as amended, the Brevort Township Board hereby transfers responsibility for the administration and enforcement of its Building and Construction Code provisions to the Bureau of Construction Codes.

Section 2. All ordinances inconsistent with the provisions of this ordinance are hereby repealed.

Section 3. This ordinance shall be effective immediately upon legal publication, in accordance with provisions of the Act governing same.
